No admission permitted to the event for vehicles without windshield sticker in place and no persons, regardless of age, will be permitted entry to the event without the proper credentials. Entry fee includes vehicle entry and admission credentials for two people to all activities of the event. Participants' children sixteen and under will be furnished admission credentials free of charge. Tickets for participants' children over sixteen will be available at the regular adult admission fee. Credentials are non-transferable after registration check-in.
